Arrival and transportation must be scheduled at least a week before the event and approved before. (An advanced itinerary from host is recommended.) \$.00 USD (**TBD**) per diem, per day, (additional to the original fee), the same day as the arrival.

Marketing expenses for master class including all promotional items needed. (High quality marketing is highly expected of the host for a successful event)^[L]_[SEP]

Proper staging and sounds suitable for expected audience. (Betsy must be able to perform a stage and sound check at least 2 hours before the event), 1 wireless hand microphone, 1 line output for Mac. Event venue expenses including rental fee, insurance policies, music license, etc.

A fee of \$800 to \$1000.00 USD is charging for the services of Betsy Dopico (**30% must be paid upon execution of the contract**) **the balance of the fees due, the event date. (TBD).**
